NOW, THEREFORE, THE TOWN BOARD OF THE TOWN OF SANBORN RESOLVES AS FOLLOWS:

All of the alleged claims for recovery of unlawful property taxes under Wisconsin Statute 74.35 filed by the above listed claimants/taxpayers are hereby disallowed.


